PLEASE NOTE:

National Championships

Details of competitors in the Women's National Championships shall be submitted by the County Association to Bowls England not later than the Monday of Week 30.

Details of competitors in the Men's National Championships shall be submitted by the County Association to Bowls England not later than the Monday of Week 31.

The first Monday of the Bowls England National Championships shall be in Week 32 of each year.

National Competitions

For details on individual National Competition submission dates, please refer to appropriate regulation.

GLOSSARY:

Challenger

In Bowls England National Competitions, the Challenger is shown on the published draw by an arrow and identified on the draw card circulated to the named contact of both teams/sides. The duties of the Challenger in National Championships and National Competitions are included within the Bowls England Regulations.

Draw for Rinks

The draw for rink/s to be played on shall be made in accordance with the current Laws of the Sport (Law 3.1). For a match requiring one rink, a minimum of two rinks shall be offered to the opponent. For a match requiring more than one rink, the minimum number of rinks offered shall be at least equal to the number of rinks required.

Bowls England Regulation: No. 50
Approved October 2018

1. Bowls England National Championships

- 1.1 County Championships leading to National Championships shall be administered by the County Association under the Rules and Regulations of Bowls England and in accordance with the current Laws of the Sport of Bowls.
- 1.2 All County Championships leading to National Championships shall be played either on weekdays in the evenings with a start time no earlier than 6pm or at weekends. For weekday games an earlier start may be arranged by mutual agreement between competitors, but in the absence of mutual agreement the start time of no earlier than 6pm shall be adhered to.
- 1.3 Should a player, who has been expelled or suspended from a Club, be drawn to play at that Club in any Championship game, other than a side game, run under the auspices of or on behalf of Bowls England, the Club shall either allow the player access to the changing room and green in order to play the game or alternatively advise the challenger(s) to make arrangements for the game to be played on a neutral green of a Club affiliated to Bowls England. Under no circumstances shall the opponent(s) be expected to concede the game. Should the expelled or suspended player be a member of a 'side team' the Club fielding the player shall ask the Club from whom he/she was banned for permission for that player to access the Club. If permission is refused the player shall be withdrawn from the side. In all other cases the Club may refuse access.
- 1.4 The National Championships shall comprise:
- Singles
 - Two-Wood Singles
 - Pairs
 - Triples
 - Fours
 - Junior Singles
 - Junior Pairs
 - Senior Fours

All others are National Competitions.

- 1.5 Players selected for approved International duties, together with Officers and Officials on duty with the England teams, shall be allowed to play in all stages of County Championships leading to National Championships should dates clash.
- 1.6 Should a club cease to exist after the entry date, the members may be permitted, for one season only, to compete under the name of that club irrespective of which club or clubs they have joined.
- 1.7 All Competitors in National Championships shall have paid affiliation fees, through their Club, for the current year.
- 1.8 The Administrator of each County Association shall forward to Bowls England, the number of entrants in each of the Championships, together with the relevant entry fees as determined by Bowls England, by the Monday of Week 5.
- 1.9 Each entry shall be made by one named player only, and that player shall be excluded from being a substitute in the same discipline. Should the named entrant in a County Championship event be unable to participate from the outset in the Championship due to exceptional circumstances, the team may request the use of an additional player if required (in addition to the original players that formed the team in the first match). Such a request shall be made in writing to Bowls England via the County Association for consideration.
- 1.10 A competitor shall not enter any Bowls England Championship under an assumed name, nor shall they represent or allow their name to be submitted by more than one Club or County, in any one year. All players

in team games shall be affiliated members of the same club **(with the exception of the Junior Pairs Championship – refer to Regulation 50.2.7)** and they may only represent that club in all championship events.

- 1.11 Any entry in a National Championship shall be declared invalid if the competitor enters in another United Kingdom country's Championship in the same year.
- 1.12 There is nothing in the Laws of the Sport or in the rules of the National Championships, as at present constituted, which stipulates that matches may not be played on a surface other than grass. However, the Challenger shall inform their opponent if there is a likelihood of play on a surface other than grass. It is, however, a condition that National Championships are played outdoors and that the green has been approved by the relevant County Association.
- 1.13 The draw for rink/s to be played on shall be made in accordance with the current Laws of the Sport **(refer to Glossary on Page 2 for definition)**.
- 1.14 Suitable flood lighting may be used during these matches.
- 1.15 Fixed groundsheets are acceptable for National Championships, however portable/moveable groundsheets are prohibited.
- 1.16 If a player/team fails to appear and be ready to play within 30 minutes after the agreed start time for the tie, the opponent/team may claim a 'walk over'.
- 1.17 The winners of the following events shall be entered by Bowls England to represent England in their respective British Isles Championship in the following season and shall adhere to the Bowls England Code of Conduct for International Players (Appendix K) including the requirements with regard to travel and accommodation:
 - National Singles Championship
 - National Pairs Championship
 - National Triples Championship
 - National Fours Championship
 - National Senior Fours Championship
 - National Junior Singles Championship
 - National Junior Pairs Championship (Women Only)

2. Championship Format

- 2.1 Singles
Each game shall consist of 21 shots – four bowls each player.
- 2.2 Pairs (Two players from the same club)
Each game shall consist of 21 ends – four bowls each player. The Leads to play their four bowls before the skips. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached.
- 2.3 Triples (Three players from the same club)
Each game shall consist of 18 ends – three bowls each player. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached.
- 2.4 Fours (Four players from the same club)
Each game shall consist of 21 ends – two bowls each player. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached.
- 2.5 Two-Wood Singles
Each game shall consist of 21 ends – two bowls each player. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached.

2.6 Junior Singles
Each game shall consist of 21 shots – four bowls each player. The Championships shall be open to all Members of Clubs affiliated to Bowls England who have not attained their 25th birthday on the 1st April in the year of the Championship.

2.7 **Junior Pairs (Two players from the same County)**
Each game shall consist of 18 ends – four bowls each player. The Leads to play their four bowls before the skips. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached. The Championships shall be open to all Members of Clubs affiliated to Bowls England who have not attained their 25th birthday on the 1st April in the year of the Championship. The two players may belong to different clubs within the same county, so long as both clubs are affiliated to Bowls England.

2.8 Senior Fours (Four players from the same club)
Each game shall consist of ~~21~~ 18 ends – two bowls each player. In the event of the scores being equal when all ends have been played, an extra end or ends shall be played until a decision is reached. The Championships shall be open to all Members of Clubs affiliated to Bowls England who have attained their 55th birthday by the 1st April in the year of the Championship.

3. Qualifiers for National Championships

3.1 Every County Association shall be entitled to two representatives in each discipline at the National Championships, who shall be the County Finalists, with the following exceptions:

- Junior Singles - The six counties with the lowest number of entries shall only have one representative.
- Junior Pairs – Winning Pair only from County
- Senior Fours – Winning Four only from County
- Singles, **Two-Wood Singles**, Pairs, Triples and Fours – All counties with 5% or more of the total number of entries in that Championship from the previous year shall be entitled to three representatives.

3.2 **The name, phone number/s, e-mail address and club of each player qualifying to compete in the final stages shall be forwarded to Bowls England via the notified method by the Monday of Week 30 for Women, and Monday of Week 31 for Men.**

4. Substitution

4.1 In Pairs, Triples and Fours, the players taking part in the first game shall constitute the team and shall normally play together throughout the Championship.

4.2 One additional, and the same player, may be used as a substitute at any time provided they have not already played in the same Championship. They may play in any position.

4.3 The named entrant conceding a walkover before their first game in any Championship cannot act as a substitute in the same Championship, as this is considered a game played and lost.

4.4 The named entrant of a team cannot be a member or substitute **of** any other team in the same Championship.

4.5 If a substitute is required during a game then the rules in the current Laws of the Sport of Bowls apply.

5. Dress

5.1 Please refer to Appendix A (Dress Code – Men) or Appendix B (Dress Code – Women) as relevant.

Bowls England Regulation: No. 51
Approved October 2018

1. National Championships – Final Stages

- 1.1 The name, phone number/s, e-mail address and club of each player qualifying to compete in the final stages shall be forwarded to Bowls England via the notified method by the Monday of Week 30 for Women, and Monday of Week 31 for Men.
- 1.2 The first Monday of the Women’s National Championships shall be in Week 32 of each year. The first Monday of the Men’s National Championships shall be in Week 34 of each year.
- 1.3 In order to avoid a duplication at the National Championships through competitors qualifying in more than one National Championship event, the designated County Official shall allocate A or B (+C if appropriate) representatives accordingly. Bowls England reserves the right to change representatives if they are incorrectly allocated.
- 1.4 The Championships shall be played under the current Laws of the Sport and in accordance with the regulations currently laid down by Bowls England. Competitors shall adhere to the Code of Conduct (Appendix C) and also posted on the Bowls England website. This shall be under the management and control of the Tournament Committee who shall determine all questions and disputes that may arise and that do not come within the scope of the Umpire’s duties, as hereinafter defined. The decision of the Tournament Committee shall be final and binding. The Tournament Committee reserves the right to alter starting times and rinks if it is considered necessary or desirable.
- 1.5 A travel subsidy may be paid to players qualifying for the National Championships in the final stages at such a rate as the Bowls England Board may from time to time determine.
- 1.6 At the final stages of all National Championships all bowls shall bear a stamp in accordance with the current Laws of the Sport of Bowls.

2. Badge Presentation and Player Registration

- 2.1 All players shall assemble in playing kit near the Badge Presentation Area (A Green) 30 minutes before the start of their first match in any National Championship event to be presented with their National Championship qualifier badge. ~~and/or year bar as appropriate~~
- 2.2 Every team (or player in Singles) shall complete an Emergency Contact Card and hand this in to the Tournament Office when reporting for their first match. An Emergency Contact Card shall be completed for all events.
- ~~2.3 Having received a badge for their first event, players receive a year bar for every other event they have qualified in.~~
- 2.3 Skips/singles players shall collect their scorecards and/or stickers from the Tournament Office before each round.
- 2.4 After the end of each match the winning skip (or player in Singles) shall take the signed scorecard/s to the Tournament Office immediately. Failure to do so may lead to disqualification.
- 2.5 Competitors not on the green ready to play within 15 minutes of the times stated on the draw sheets shall be subject to disqualification.

3. Substitution

- 3.1 All substitutes shall be registered with the Tournament Office.

4. Slow Play

- 4.1 Competitors shall adhere to the Bowls England Slow Play Guidance (Appendix D) and also posted on the Bowls England website.

5. Parental Consent

- 5.1 Parental consent forms (where applicable) shall be completed and submitted.

6. Conclusion of Matches

- 6.1 Matches shall be conceded where it is not possible for the losing team/individual to win to assist with the National Championship Finals schedule.

7. Green Fit for Play

- 7.1 The Greenkeeper and/or Tournament Director shall be the adjudicators as to whether or not the green is fit for play and shall have the power to postpone play at any point. Should play be postponed the current Laws of the Sport of Bowls shall apply.

8. Trophy Presentation

- 8.1 At the conclusion of all Finals, a presentation shall take place on the green. If the award of prize money or gifts is applicable then at least one member from each of the losing Semi-Finalists shall attend shall attend **in playing uniform**, otherwise their prize money shall be withheld and donated to the Charity Trust. The exception to this rule is for any event that holds the Semi-Finals and Final on separate days. The Winners of the Singles (Four-Wood), Junior Singles, Junior Pairs (Women Only), Pairs, Triples, Fours and Senior Fours shall represent England in the British Isles Championships the following year.
- 8.2 The Winners shall be presented with the trophy, medal/s and fleece/s at the Annual Dinner. The Runners-Up and Semi-Finalists shall also receive medals at the Annual Dinner.

9. Dress

- 9.1 Please refer to Appendix A (Dress Code – Men) or Appendix B (Dress Code – Women) as relevant.

Bowls England Regulation: No. 52
Approved October 2018

1. Bowls England National Competitions

1.1 The National Competitions shall be played under the current Laws of the Sport of Bowls and in accordance with the Regulations currently laid down by Bowls England. All competitors shall adhere to Appendix C (Code of Conduct), also posted on Bowls England website.

1.2 All National Competitions shall be controlled by the Competitions Committee Bowls England. An Emergency Committee shall consist of any three members of the Competitions Committee and/or Competitions Assistants nominated by the Director of Competitive Events. The decision of either the Emergency Committee in each and every circumstance shall be final and binding.

1.3 Should a player, who has been expelled or suspended from a Club, be drawn to play at that Club in any National Competition game, other than a side game, run under the auspices of or on behalf of Bowls England, the Club shall either allow the player access to the changing room and green in order to play the game or alternatively advise the challenger(s) to make arrangements for the game to be played on a neutral green of a Club affiliated to Bowls England. Under no circumstances shall the opponent(s) be expected to concede the game. Should the expelled, or suspended player be a member of a 'side team' the Club fielding the player shall ask the Club from whom he/she was banned for permission for that player to access the Club. If permission is refused the player shall be withdrawn from the side. In all other cases the Club may refuse access.

1.4 National Competitions consist of the following;

- Johns Trophy – Inter-County Competition (Women)
- Walker Cup – Inter-County Top Two Fours Competition (Women)
- Amy Rose Bowl – Inter-County Junior Competition (Women)
- National Senior Singles and Pairs Competition (Women)
- National Top Club Competition (Women)
- National Family Pairs Competition
- National Champion of Champions Singles Competition (Women)
- Middleton Cup – Inter-County Competition (Men)
- National Club Two Fours Competition (Men)
- National Top Club Competition (Men)
- National Senior Singles and Pairs Competition (Men)
- National Champion of Champions Singles Competition (Men)
- Balcomb Trophy – Inter-County Top Two Fours Competition (Men)
- White Rose – Inter-County Junior Competition (Men)
- National Mixed Pairs Competition
- National Mixed Fours Competition
- Tony Allcock Trophy – National Club Mixed Over 60s Double Rink Competition

In any year a competitor selected to play in Inter-County Competitions (as listed above) may only represent the county from which they have entered National Championships.

All others events not listed in 1.4 above are National Championships.

1.5 Should a club cease to exist after the entry date, the members may be permitted, for one season only, to compete under the name of that club irrespective of which club or clubs they have joined.

1.6 Should a club cease to exist prior to the entry date, the Singles Champion shall be eligible for one season only to enter the Champion of Champions under the name of their previous club.

1.7 All Competitors in National Competitions shall have paid affiliation fees, through their Club, for the current year.

- 1.8 The Administrator of each County Association shall forward to the Chief Executive of Bowls England, the entries in each of the Walker Cup, Johns Trophy, Middleton Cup, Balcomb Trophy and White Rose together with the relevant entry fees as determined by Bowls England, by the Monday of Week 5. Entries for the Amy Rose Bowl shall be received by the Monday of Week 14. The remaining competitions are directly administered by Bowls England.
- 1.9 Competitors shall not enter any Bowls England Competition under an assumed name.
- 1.10 There is nothing in the Laws of the Sport or in the rules of the National Competitions, as at present constituted, which stipulates that matches may not be played on a surface other than grass. However, the Challenger shall inform their opponent if there is a likelihood of play on a surface other than grass. It is, however, a condition that National Competitions are played outdoors and that the green has been approved by the relevant County Association.
- 1.11 Suitable flood lighting may be used during these matches.
- 1.12 The format of Rules for the individual National Competitions shall be found under the Regulations applicable to each National Competition.
- 1.13 The draw and completion dates for all National Competitions shall be made by Bowls England. Each County shall decide if the National Competition area shall be played on a County, Regional or Open basis as deemed applicable. Area draws shall be based upon the entry figures from the previous year.
- 1.14 In all qualification rounds, the Challenger shall be responsible for the match arrangements.
- 1.15 The Challenger shall be responsible for the payment of rink fees (where applicable), except when matches take place at a neutral venue when all costs shall be shared by both participants/teams/sides.
- 1.16 Matches shall be played on a green approved by the County Association and chosen by the Challenger. Where the mileage exceeds 160 miles round trip (measured club to club for club-based events and County Centre to host venue for county-based events) matches shall be played on a neutral green approximately midway between the two clubs/counties unless mutually agreed.
- 1.17 All final qualification rounds shall be played on a neutral green midway between the two clubs (unless mutually agreed).
- 1.18 The Challenger shall offer their opponent within 48 hours of the closing date of the previous round at least three dates for play, one of which shall be a Saturday or Sunday. The offering of two different start times on a single date does not count as two dates. A minimum of 48 hours' notice is required for any dates offered to be eligible. The time for commencing a match shall be mutually agreed but no player/team/side shall be compelled to accept a time earlier than 6.00pm Monday to Friday or 9.30am on a Saturday or Sunday, nor later than 6.30pm on any day.
- 1.19 The Opponent or Opposing teams/sides shall, within 24 hours of receipt of the challenge, reply and accept one of the dates offered.
- 1.20 When a draw and result card is issued in advance of the start of the Competition, the Challenger does not need to offer dates until 21 days before the closing date of the first match, nor does the opponent need to accept a date until 19 days before the closing date of that round, after which the aforesaid conditions shall apply.
- 1.21 If a challenge has not been made within the specified period, the opponent shall become the Challenger and make all match arrangements including the offering of dates and choice of venue.
- 1.22 No extension of the closing date for any round shall be granted for any reason whatsoever.
- 1.23 If the time scales for arranging any match are not met by either the Challenger or Opponent, the matter shall be referred to the Bowls England Emergency Committee to adjudicate.

- 1.24 The draw for rink/s to be played on shall be made in accordance with the current Laws of the Sport (refer to Glossary on Page 2 for definition).
- 1.25 If a player/team/side fails to appear and be ready to play within 30 minutes after the agreed time for the tie, the opponent may claim a 'walk over'.
- 1.26 In the event of no decision being reached IN ANY ROUND owing to inclement weather, and where this makes it impossible to re-arrange a fixture before the completion date, the aggregate score, in uncompleted matches in which five ends or more have been played, shall stand as the result unless otherwise specified. If the score is a tie then the result shall be decided by the toss of a coin. Matches not started and matches in which less than five ends have been completed shall be decided by the toss of a coin, or by mutual agreement. This Regulation does not apply to Top Club (Men's and Women's)/Club Two Fours/Tony Allcock Trophy/Johns Trophy/Middleton Cup/Walker Cup/Balcomb Trophy/Amy Rose Bowl/White Rose Trophy – see Appendix J for these events.
- 1.27 Fixed groundsheets are acceptable for National Competitions; however portable/moveable groundsheets are prohibited.
- 1.28 The result shall be submitted by the winning player or team/side to Bowls England immediately using one of the approved notification methods.
- 1.29 Regional Finals, where required, shall be played at venues selected by Bowls England. Players shall be informed of the venues and details by Bowls England.

2. Substitution

- 2.1 The named entrant conceding a walk-over before their first match in any National Competition cannot act as a substitute in the same competition, as this is considered a match played and lost.
- 2.2 The named entrant of a team cannot be a member or substitute of any other team in the same National Competition.
- 2.3 If a substitute is required during a match then the rules in the current Laws of the Sport of Bowls apply.
- 2.4 See individual National Competition Regulation for substitution rules.

3. Dress

- 3.1 Please refer to Appendix A (Dress Code – Men) or Appendix B (Dress Code – Women) as relevant.

Bowls England Regulation: No. 53
Approved October 2018

Johns Trophy – Inter-County Competition (Women)

This regulation should be read in conjunction with Regulation 52 – National Competitions.

1. This competition shall be open to all County Associations who are Members of Bowls England.
2. All Counties shall be assumed to have entered unless they otherwise notify Bowls England before the completion of the previous year's competition.
3. Any team withdrawing from the Johns Trophy after 1st April of that year shall be ineligible to participate in the Walker Cup in the following year.
4. The entrants shall be placed in geographical groups, which shall remain the same, but the composition of the sections shall be determined by a draw made every second year.
5. The competition shall be divided into two stages – the Group Stages and the Final Stages. In the Group Stages each county shall play one match each year against each other County in their section, home and away alternate years or at a neutral venue for both years. Matches shall start at 1.30pm unless mutually agreed. ~~At the last round of group games, (excluding dead rubbers), all games must start at 1.30pm.~~ **The last round of group games within the same group, (excluding dead rubbers), shall start at the same time (1.30pm unless mutually agreed between all competing counties).**
6. Every County shall be represented by a side consisting of six rinks of four players, all of whom shall be members of an affiliated club to their County Association. No player shall play for more than one County in any one year.
7. Failure to field 24 players shall result in a walkover and 22 points shall be awarded to the opposing team. Where a county refused to fulfil the fixture the following penalty shall apply; 22 points shall be awarded to the non-defaulting team and the defaulting team shall be excluded from entering the Johns Trophy and the Walker Cup the following year.
8. **Group Stages**
 - 8.1 The match shall consist of 21 ends. Before the start of the match, the nominated managers shall toss a coin for the choice of jack (first end), the winner having the choice of keeping or giving the jack away. Then a further toss of a coin for choice of jack (extra end) should one be needed. The winner has the option to make the choice immediately after the 21st end has been played. In each match a win for an individual rink shall be awarded two points and a tie one point. The county that wins by total number of shots of all six rinks shall, in addition, be awarded 10 points. In the event of a tie on shots, each county shall be awarded five points each.
 - 8.2 The county gaining the greatest number of points in each section shall be declared the winner of that section. Should two counties be equal in points and also in shot difference then the winner shall be ascertained on the result of the match already played between the two counties.
 - 8.3 In the group stages, should a match end as a tie (both shots and points) after 21 ends then an extra end or ends shall be played by all six rinks simultaneously until there is a winner. The total number of shots on all six rinks shall count on the extra end and the winning team reported to Bowls England. The extra end shall not form part of the score within the group stages, but shall ONLY be used to separate the two counties if they are level at the conclusion of the group stages after points and shots difference have been taken into account.
 - 8.4 When it is not mathematically possible to win by playing a scheduled tie and subject to this being ratified by Bowls England, such a tie may be cancelled. The Counties concerned shall be in mutual agreement and would each be responsible for the reimbursement of expenses incurred by the venue booked.
9. **Result of Match**

The result shall be submitted to Bowls England immediately using one of the approved notification methods.

10. Bowls Stickers
Counties shall provide bowls stickers for the Group Stages and Quarter-Finals unless provided by the sponsor.

11. Inclement weather
See Appendix J

12. Final Stages

12.1 The Quarter-Finals shall be played on a knockout basis at a time set by Bowls England. These shall be played between the winners of the two sections in each geographical group. The two counties concerned shall be responsible for arranging an Umpire and a neutral venue midway between the two counties. If green fees are payable these shall be shared by both counties. Before the start of the match, the nominated managers shall toss a coin for the choice of jack (first end), the winner having the choice of keeping or giving the jack away. Then a further toss of a coin for choice of jack (extra end) should one be needed. The winner has the option to make the choice immediately after the 21st end has been played. 6. A player under the age of 12 years on the 1st April in the year of the competition may be substituted after eight ends have been played.
7. Junior/Cub bowls may be used.
8. The match shall consist of 15 ends. Before the start of the match, the nominated managers shall toss a coin for choice of jack (first end), the winner having the choice of keeping or giving the jack away. Then toss a coin to nominate which rink shall play the extra end. The winner to nominate the name of the skip to play the extra end. This shall be declared prior to the match commencing. A further toss of a coin for choice of jack (extra end) should one be required. The winner has the option to make the choice immediately after the 15th end has been played. The total number of shots on both rinks shall determine the winner. In the event of a tie after 15 ends then an extra end shall be played by the nominated rink to determine the overall winner.

5. Failure to field 10 players shall result in a walk-over.

6. Before the start of the match, the nominated managers shall toss a coin for the choice of jack (first end), the winner having the choice of keeping or giving the jack away, and make the draw for rinks for each discipline. The format for the competition shall be as follows:

- 1pt for every discipline won, total of four points available. In the event of a drawn discipline the point shall be shared, i.e. ½ point each. After completion of the four disciplines the winning side shall be decided by the highest number of points.
- In the case of a tie, the winner shall be decided from the total number of shots scored from the four disciplines. 8. **Group Stages**

In the event of a substitute being required in the Senior Pairs, one and the same player may come from any club, in the same county, providing they have not already played in the same competition, however, one of the original players shall play in all rounds. The substitute may play in any position.

 - 7.3 Bowls England shall provide bowls stickers for the final stages of this event
 - 7.4 The Winners shall be presented with a medal and fleece for the singles or two medals and two fleeces for the pairs at the Annual Dinner with one or two medals respectively for the Runners-Up.

Bowls England Regulation: No. 64

National Champion of Champions Singles Competition (Men)

This regulation should be read in conjunction with Regulation 52 – National Competitions.

1. The competition shall be open to all clubs affiliated to Bowls England.
2. Players eligible to enter are as follows:
 - Club Four-Wood Singles Champion
 - County Four-Wood Singles Champion
 - County Junior Four-Wood Singles Champion
 - Area **National** Senior Singles Qualifier from previous year.

All the above shall be nominated by their Club or County.

In addition the Champions of the following events from the previous year have automatic entry from Bowls England:

- ~~The previous year's~~ National Champion of Champions
- ~~The previous year's~~ National Four-Wood Singles Champion
- ~~The previous year's~~ National Junior Four-Wood Singles Champion
- ~~The previous year's~~ National Senior Singles Champion

In the event of any one person qualifying in more than one of the aforementioned, only one entry shall be accepted.

3. Entries shall be made on the official entry form duly signed by the Club or County Secretary, who shall certify that the nominated player is qualified to enter.

4. **Players who have moved clubs during the close season shall still be eligible to enter the Champion of Champions providing that Bowls England receives written approval from the Club or County Secretary where they secured qualification no later than 1st February in the year of the event.**

5. Each match shall be 21 shots, four bowls each player.

6. Final Stages

- 6.1 The final stages consisting of the last 16 Competitors shall be played on a knockout basis at a time set by Bowls England during the National Championships. The draws for these shall be made by Bowls England.

Balcomb Trophy - National County Top Two Fours Competition (Men)

This regulation should be read in conjunction with Regulation 52 – National Competitions.

1. The competition shall be open to all County Associations who are members of Bowls England.
2. Every County shall be represented by a side consisting of two rinks of four players.
3. Failure to field eight players shall result in a walk-over.
4. All Counties shall be assumed to have entered unless they otherwise notify Bowls England before the completion of the previous year's competition.
5. ~~The preliminary round and first round will be played by mutual arrangement on the designated dates.~~ The competition shall be played on a knockout basis, with the early rounds in geographical areas. Each rink of a side shall play 21 ends, two bowls each player. The challenger shall make all match arrangements **in accordance with the National Competition regulations.** Arrangements for cost of refreshments and other incidental expenses shall be a domestic matter.
6. Before the start of the match, the nominated managers shall toss a coin for choice of jack (first end), the winner having the choice of keeping or giving the jack away. Then toss a coin to nominate which rink shall play the extra end. The winner to nominate the name of the skip to play the extra end. This shall be declared prior to the match commencing. A further toss of a coin for choice of jack (extra end) should one be required. The winner has the option to make the choice immediately after the 21st end has been played. The total number of shots on both rinks shall determine the winner. In the event of a tie after 21 ends then an extra end shall be played by the nominated rink to determine the overall winner.
7. Inclement weather

8. Counties shall inform the Regional Selector of date/time and venue of preliminary/first round matches. The result shall be submitted to Bowls England immediately using one of the approved notification methods.
9. **Final Stages**

The Semi-Final and Final shall be played during the National Championships. A maximum of 10 National Competition badges shall be presented to players involved at the National Championships.

 - 9.4 The Winner and Runner-Up shall receive a maximum of 10 Winner/Runner-Up medals respectively presented at the Annual Dinner.

White Rose National County Junior Competition (Men)

This regulation should be read in conjunction with Regulation 52 – National Competitions.

1. The competition shall be open to all County Associations who are members of Bowls England.
2. Every County shall be represented by a side consisting of one rink of four players. All players shall be members of clubs affiliated to their County Association and have not attained their 25th birthday by 1st April in the year of the competition.
3. Counties can enter up to two teams, who shall be situated in separate halves of the draw with no possibility of meeting until the National Final.
4. Failure to field four players (in any single team) shall result in a walk-over.
5. Counties shall notify Bowls England by the 1st October annually whether they wish to enter the following year's competition, along with their team name/s. If entering more than one team, each team shall be allocated a team name (no team should be classified as A/B or similar).
6. The competition shall be played on a knockout basis, with the early rounds in geographical areas. Each match shall be 15 ends, two bowls each player. The challenger shall make all match arrangements in accordance with the National Competition regulations. Arrangements for cost of refreshments and other incidental expenses shall be a domestic matter.
7. Before the start of the match, the nominated managers shall toss a coin for choice of jack (first end), the winner having the choice of keeping or giving the jack away. A further toss of a coin for choice of jack (extra end) should one be required. The winner has the option to make the choice immediately after the 15th end has been played.
8. Inclement weather

9. Counties shall inform the Regional Selector of date/time and venue of preliminary round matches. The result shall be submitted to Bowls England immediately using one of the approved notification methods.
10. **Final Stages**
 - 10.1 The final stages consisting of the Regional Finals, Semi-Finals and the Final shall be played on a knockout basis at a time set by Bowls England. The draw for all rounds shall be made by Bowls England.
 - 10.2 Each county qualifying for the Quarter-Final stage shall supply to Bowls England the names of its rink and reserve no later than the Monday of Week 29. The Quarter-Finals, Semi-Finals and Final shall be played during the National Championships. A maximum of five National Competition badges shall be presented to players involved at the National Championships.
 - 10.3 Bowls England shall provide bowls stickers for the final stages of this event.
 - 10.4 The Winners and Runners-Up respectively shall receive a maximum of 5 Winners medals presented at the Annual Dinner.

One and the same male and/or one and the same female player may be used as a substitute at any time, providing that they have not already played or entered the same competition. However, at least one of the original pair shall play in every round.
6. **Final Stages**
 - 6.1 The Final stages consisting of the last 16 teams shall be played on a knockout basis at a time set by Bowls England during the National Championships.
 - 6.2 Each Team qualifying for the final stages shall supply to Bowls England the name of each player no later than the Monday of Week 30. The players involved in the final stages shall receive a National Competition Badge.
 - 6.3 Bowls England shall provide bowls stickers for the final stages of this event.
 - 6.4 The Winners shall be presented with two medals and two fleeces at the Men's Annual Dinner along with two medals for the Runners-Up.

 - 6.3 Bowls England shall provide bowls stickers for the final stages of this event.
 - 6.4 The Winners shall be presented with four medals and four fleeces at the Men's Annual Dinner along with four medals for the Runners-Up.

Tony Allcock Trophy – National Club Mixed Over 60s Double Rink Competition

This regulation should be read in conjunction with Regulation 52 – National Competitions.

1. The competition shall be open to all Clubs affiliated to Bowls England. Clubs may enter more than one side. No player shall play in more than one of those sides entered.
2. All players shall be aged 60 years or over on April 1st in the year of the competition.
3. Players are required to play from the club in which they play their National Championships. Players entering National Championships in another country are not eligible to participate.
4. A club side shall consist of two rinks of four **players from its membership in accordance with the National Competition regulations** (two men and two women per rink) and they shall play **24 18** ends, two bowls each player. The challenger shall have the choice of green and shall make all match arrangements. **up to the inter-area stage.**
5. Failure to field eight players shall result in a walk-over.
6. Before the start of the match, the nominated managers shall toss a coin for choice of jack (first end), the winner having the choice of keeping or giving the jack away. Then toss a coin to nominate which rink shall play the extra end. The winner to nominate the name of the skip to play the extra end. This shall be declared prior to the match commencing. A further toss of a coin for choice of jack (extra end) should one be required. The winner has the option to make the choice immediately after the **24th 18th** end has been played. The total number of shots on both rinks shall determine the winner. In the event of a tie after **24 18** ends then an extra end shall be played by the nominated rink to determine the overall winner.

~~7.1 The draw for the inter area stage will be made by Bowls England. The challenging side will arrange a neutral green as equidistant as possible (measured from Club to Club).~~

A maximum of 10 National Competition badges shall be presented to players involved at the National Championships.
- 8.3 Bowls England shall provide bowls stickers for the final stages of this event.
- 8.4 The Winners shall receive a maximum of 10 Winners medals, fleeces and a Club Pennant with the Runners-Up receiving a maximum of 10 medals that shall be presented at the Men's Annual Dinner.

- b) Club/County apparel may be worn provided that all members of the side or team wear the same and provided that the design of such apparel has been registered to the County/Bowls England.
- c) Bowls England licensed and approved apparel (e.g. shorts) may be worn provided that all members of a side or team wear the same colour above and/or below the waist.
- d) Players governed by requirements of a specific ethnic culture shall be permitted to wear their traditional dress if they so desire.
- e) Tracksuits, shell suits and jeans are not acceptable.
- f) Headgear, if worn, should be white or a registered colour.
- g) Socks, if visible, should be white.
- h) White waterproof clothing may be used, or, providing all members of a side or team wear the same, registered colour waterproof/fleeces are permitted. Bowls England licensed and approved apparel may also be worn.

- c) Bowls England licensed and approved apparel (e.g. shorts) may be worn provided that all members of a side or team bear the same colour above and/or below the waist.
- d) Players governed by requirements of a specific ethnic culture shall be permitted to wear their traditional dress if they so desire
- e) Tracksuits, shell suits and jeans are not acceptable.
- f) Headgear, if worn, should be white or a registered colour.
- g) Socks, if visible, should be white.

- c) Bowls England licensed and approved apparel (e.g. shorts) may be worn provided that all members of a side or team wear the same colour above and/or below the waist.
- d) Players governed by requirements of a specific ethnic culture shall be permitted to wear their traditional dress if they so desire.
- e) Tracksuits, shell suits and jeans are not acceptable.

 - d) Players governed by requirements of a specific ethnic culture shall be permitted to wear their traditional dress if they so desire.

Sandals shall not be permitted in events under the jurisdiction of Bowls England except in medical circumstances where a doctor's note has been provided.
- b) Club/County apparel may be worn provided that all members of the side or team wear the same and provided that the design of such apparel has been registered to the County/Bowls England.
- c) Bowls England licensed and approved apparel (e.g. shorts) may be worn provided that all members of a side or team wear the same colour above and/or below the waist.
- d) Players governed by requirements of a specific ethnic culture shall be permitted to wear their traditional dress if they so desire
- e) Tracksuits, shell suits and jeans are not acceptable.
- f) Headgear, if worn, should be white or a registered colour.
- g) Socks, if visible, should be white.

2.5 Tights or stockings are optional at all times. If worn they must be in shades of brown.

Appendix C: Code of Conduct

Competitors in Bowls England National Championship/Competition Finals

This code of conduct applies to all players who participate in the Bowls England National Championship and National Competition Finals, and is to be read in conjunction with the Bowls England Regulations for National Championships and National Competitions.

All players who participate in the National Championship and Competition Finals, at whichever prescribed venue, shall at all times conduct themselves in such a manner that reflects favourably upon themselves, Bowls England and the County or Club that he/she is representing at national level.

In particular he/she should:

1. Report punctually at the prescribed time and place.
2. Be conversant with and comply with the Laws of the Sport of Bowls and all Bowls England domestic rules and by-laws relating to National Championships and National Competitions.
3. Adhere to Bowls England's Betting Integrity Guidance (Bowls England Regulation No.4.6)
4. Adhere to Bowls England's Disciplinary Regulations (Bowls England Regulation No.9, No.9A or No.9B apply as applicable)
5. Adhere to Bowls England's Anti-Doping Guidance (Please refer to Bowls England website)
6. Adhere to Bowls England Equality Policy (Please refer to Bowls England website)
7. ~~Play all matches to completion i.e. to the required number of shots or ends. However,~~ Matches may be conceded at any time, but shall be conceded where it is not mathematically possible for the losing participant/team/side to win. ~~Otherwise matches may only be conceded in the case of illness or otherwise at the discretion of the Tournament Director (or nominated deputy).~~
8. Not cheat in order to gain unfair advantage, or cheat in order to deliberately lose a game.
9. Not use any form of gamesmanship in an attempt to gain unfair advantage.
10. Comply strictly with the guidance relating to 'slow play' (Appendix D).
11. Not render himself/herself unfit through alcohol or drugs on or off the bowling green.
12. Show respect to colleagues, opponents and officials and not subject them to any physical or verbal abuse at any time.
13. Smoking on the green is prohibited during all games (see Appendix G).
14. The use of mobile phones on the green is prohibited during all games.

Failure to adhere to the above shall result in an initial warning that shall be issued by a nominated Umpire. Should the player continue to not adhere they shall be subject to disqualification at the discretion of the Tournament Director (or Nominated Deputy), whose decision shall be final.

Appendix D: Slow Play

The following shall be enforced in the final stages of all Bowls England National Championships and Competitions. Only the Tournament Director (or Nominated Deputy) can disqualify players.

- 1 Four-Wood Singles – Neither player may visit the head until both have delivered three bowls each. Should a player wish to visit the head prior to this point being reached the permission of the marker shall be obtained. The maximum time that a player may deliberate before playing a bowl is two minutes, the time being calculated from the time the previous bowl played came to rest. Should this rule be breached they shall be warned by the marker. Any further non-compliance shall be reported by the Marker to an Umpire in charge of the green. The Tournament Director (or Nominated Deputy) may disqualify the offending player from taking any further part in the competition.
- 2 Two-Wood Singles – Neither player may visit the head until both have delivered one bowl each. Should a player wish to visit the head prior to this point being reached the permission of the marker shall be obtained. The maximum time that a player may deliberate before playing a bowl is two minutes, the time being calculated from the time the previous bowl played came to rest. Should this rule be breached they shall be warned by the marker. Any further non-compliance shall be reported by the Marker to an Umpire in charge of the green. The Tournament Director (or Nominated Deputy) may disqualify the offending player from taking any further part in the competition.
- 3 Pairs – Neither Lead may visit the head until both players have delivered three bowls each. There is no restriction on Skips revisiting the head should they wish to do so. The maximum time that a player may confer before delivering a bowl is two minutes, the time being calculated from the time the previous bowl played came to rest. Should this rule be breached and not picked up by an Umpire in charge of the green, the aggrieved opposing Skip should bring the notice of the infringement to the Umpire. The Skip of the offending Pair be warned by the Umpire and should there be further non compliance the Tournament Director (or Nominated Deputy) may disqualify the offending Pair from taking any further part in the competition.
- 4 Triples – Neither Lead may visit the head until both have delivered their three bowls each. The Second players, having left the head after the Leads have delivered their bowls may not return to the head until both players have delivered two bowls each. There is no restriction on Skips revisiting the head should they wish to do so. The maximum time that a player may confer before delivering a bowl is two minutes, the time being calculated from the time the previous bowl played came to rest. Should this rule be breached and not picked up by an Umpire in charge of the green, the aggrieved opposing Skip should bring the notice of the infringement to the Umpire. The Skip of the offending Triple shall be warned by the Umpire and should there be further non compliance the Tournament Director (or Nominated Deputy) may disqualify the offending Triple from taking any further part in the competition.
- 5 Fours – The Lead and Second players may not visit the head until all four players have delivered their two bowls. There is no restriction on the Third players or the Skips revisiting the head should they wish to do so. The maximum time that a player may confer before delivering a bowl is two minutes, the time being calculated from the time the previous bowl played came to rest. Should this rule be breached and not picked up by an Umpire in charge of the green, the aggrieved opposing Skip should bring the notice of the infringement to the Umpire. The Skip of the offending Four shall be warned by the Umpire and should there be further non compliance the Tournament Director (or Nominated Deputy) may disqualify the offending Four from taking any further part in the competition.

Appendix E: Bowls

- 1.1. All bowls shall bear a clearly legible stamp which has an expiry date of 1985 or later. These bowls can be used for the rounds leading to the final stages of the National Championships and National Competitions. All bowls shall be from the same set as stated in the laws of the Sport 52.1.9.
- 1.2. Bowls that do not meet the requirements of 1.1 shall not be used.
- 1.3. In the rounds leading to the final stages of the National Championships and National Competitions when no Umpire is present, the opposing player or players shall check the legality of the date stamp on each other's bowls.
- 1.4. The stamp on bowls, used by competitors who have reached the final stages of National Championships or National Competitions, shall comply with The Laws of the Sport 53. Domestic Regulations for Bowls England also apply.
- 1.5. Should a player wish to challenge the suitability of their opponent's bowls, as regards the bias, they should refer to The Laws of the Sport 52.4 and 52.5. Bowls England Domestic Regulations also apply. The fee to be lodged shall be £50.

Appendix F: Umpires

Umpires, when officially present, shall be appointed to officiate by the County Association or Bowls England in conjunction with the English Bowls Umpires Association. and shall determine such points as may arise during the course of the play and the application of Bowls England Regulations and 'Laws of the Sport of Bowls' thereto. Their decision shall be final.

Appendix G: Smoking and Anti-Doping

Smoking on the green is prohibited during all matches played under the jurisdiction of Bowls England. For the purpose of clarification the 'green' in this instance is deemed to include a minimum of 1 metre of the bank surrounding the playing area. Should the Club where the game is being played have a total ban on smoking on its premises, the Club prohibition shall apply. Failure to adhere to this shall result in disqualification. This prohibition includes all electronic cigarettes.

The Anti-Doping rules of Bowls England are the UK Anti-Doping Rules published by UK Anti-Doping (or its successor), as amended from time to time. Such Rules shall take effect from 1st July 2010. The UK Anti-Doping Rules can be viewed at: www.ukad.org.uk/documents/uk-anti-doping-rules

Appendix H: Protection Safeguarding of Junior Bowlers and Adults at Risk

Bowls England has a Safeguarding Policy and Adults at Risk Policy, which recognises and acknowledges its responsibilities to safeguard the welfare of young persons and adults at risk participating in its activities. More information can be found at: www.safeguardingbowls.org

Appendix I: Players with Disabilities

Wheelchairs shall be of a type approved by Bowls England following consultation with relevant disability bowls organisations. The four types currently recognised for use in England are the 'Bradshaw Buggy', 'Chariot', 'Clippy' and the 'Para-Handy'.

The wheelchair shall be recognised as being an integral part of the wheelchair player in all instances when a jack or bowl is displaced or interfered with by the wheelchair as per the current Laws of the Sport of Bowls.

At the point of delivery of the jack or bowl, refer to the current Laws of the Sport of Bowls.

Walking frames shall be of a type approved by Bowls England following consultation with relevant disability bowls organisations. The types currently recognised for use in England are the 'Rollator', 'Bowls Buddy' and the 'Bowls Walker'.

Artificial devices may be used by players with disabilities for delivering the jack or bowl provided they are approved by Bowls England following consultation with relevant disability bowls organisations.

The individual shall decide before a game starts if they are going to use an aid. If they decide to then they shall use it for the duration of that game.

Visually impaired bowlers can use any form of assistance necessary (including having an assistant with them) to allow them to take part as long as the assistance is approved by Bowls England. The assistant shall not be deemed to be in contravention of the Laws of the Sport if that assistant relays to the player the instruction of the skip, assists in directing the player or keeps the player informed as to where the jack or bowl finished after delivery.

Players with a hearing disability may use aids (i.e. walkie-talkies) in line with the current Laws of the Sport of Bowls.

Appendix J: Inclement Weather

Inclement weather shall mean the existence of rain or abnormal climatic conditions (whether they be those of hail, snow, cold, high wind, extreme high temperature or any combination thereof) by virtue of which it is either not reasonable or possible to play.

Unusual situations not covered within the above can often arise. If a situation arises that is not covered by the above, Players, Markers, Umpires and Officials shall use their common sense and a spirit of fair play to decide on the appropriate course of action.

In the event of inclement weather and no play/no further play being possible as determined by Tournament Director, Umpire and/or Greenkeeper (or players if no officials are in attendance) the following shall apply as relevant:

Middleton Cup/Johns Trophy

1. When a match is stopped by the Umpire and/or the Greenkeeper play shall cease on all rinks simultaneously. Ends started but not completed shall be declared 'dead'.
2. When it is not possible to resume the match on the day:
 - a. If the total number of ends played equals or exceeds 42 the match shall be deemed to have been completed and the score shall stand.
 - b. If the total number of ends played is less than 42, the remainder of the match shall be played at a later date (please refer to 'Law 32: Game Stoppages' for guidance).
3. The participating counties shall agree a date for any postponed/abandoned match/es to be played.
4. Bowls England shall make the final decision on the date/venue of a postponed/abandoned match/es should participating counties be unable to agree amicably.
5. At National Finals, the decision of the Tournament Director on postponed/abandoned matches shall be final.

Balcomb Trophy/Walker Cup

1. When a match is stopped by the Umpire and/or the Greenkeeper play shall cease on all rinks simultaneously. Ends started but not completed shall be declared 'dead'.
2. When it is not possible to resume the match on the day:
 - a. If the total number of ends played equals or exceeds 14 the match shall be deemed to have been completed and the score shall stand.
 - b. If the total number of ends played is less than 14, the remainder of the match shall be played at a later date (please refer to 'Law 32: Game Stoppages' for guidance).
3. The participating counties shall agree a date for any postponed/abandoned match/es to be played.
4. Bowls England shall make the final decision on the date/venue of a postponed/abandoned match/es should participating counties be unable to agree amicably.
5. At National Finals, the decision of the Tournament Director on postponed/abandoned matches shall be final.

Amy Rose Bowl/White Rose Trophy

1. When a match is stopped by the Umpire and/or the Greenkeeper play shall cease on all rinks simultaneously. Ends started but not completed shall be declared 'dead'.
2. When it is not possible to resume the match on the day:
 - a. If the total number of ends played equals or exceeds 10 the match shall be deemed to have been completed and the score shall stand.
 - b. If the total number of ends played is less than 10, the remainder of the match shall be played at a later date (please refer to 'Law 32: Game Stoppages' for guidance).
3. The participating counties shall agree a date for any postponed/abandoned match/es to be played (White Rose Trophy only).
4. Bowls England shall make the final decision on the date/venue of a postponed/abandoned match/es should participating counties be unable to agree amicably (White Rose Trophy only).
5. At National Finals, the decision of the Tournament Director on postponed/abandoned matches shall be final.

Tony Allcock Trophy/Club Two Fours

1. When a match is stopped by the Umpire and/or the Greenkeeper (or players if no officials are in attendance) play shall cease on all rinks simultaneously. Ends started but not completed shall be declared null and void.
2. When it is not possible to resume the match on the day:
 - a. *If the total number of ends played equals or exceeds 10 the match shall be deemed to have been completed and the score shall stand.*
 - b. *If the total number of ends played is less than 10, the remainder of the match shall, wherever possible, be played at a later date (please refer to 'Law 32: Game Stoppages' for guidance).*
3. Should it not be possible to play the match to its conclusion by the closing date of the round, the winner shall be decided by the toss of a coin.
4. At National Finals, the decision of the Tournament Director on postponed/abandoned matches shall be final.

Top Club

1. When a match is stopped by the Umpire and/or the Greenkeeper (or players if no officials are in attendance) play shall cease on all rinks simultaneously. Ends started but not completed shall be declared null and void.
2. When it is not possible to resume the match on the day:
 - a. *If the total number of ends played in each discipline equals or exceeds five the match shall be deemed to have been completed and the score shall stand.*
 - b. *If the total number of ends played in each discipline is less than five, the remainder of the match shall, wherever possible, be played at a later date (please refer to 'Law 32: Game Stoppages' for guidance).*
3. Should it not be possible to play the match to its conclusion by the closing date of the round, the winner shall be decided by the toss of a coin.
4. At National Finals, the decision of the Tournament Director on postponed/abandoned matches shall be final.

Appendix K: International Code of Conduct

This code of conduct shall apply to all Bowls England International Players.

An International Player is defined as any person chosen as a Player or Reserve for Senior or Junior International duty or in any Trial Team or Squad selected by Bowls England.

A bowler shall, at all times, conduct himself/herself in a manner that reflects favourably upon fellow bowlers and Bowls England both on and off the Bowling Green.

He/she shall have the following obligations:

1. Shall attend any squad get-together, training day, practice match or event appertaining to his/her selection.
2. Observe at all times the relevant Rules and Regulations of Bowls England, World Bowls and any other body responsible for the organisation of the event.
3. Accept control by the appropriate Team Manager in all matters as follows:
 - a) Dress – both on and off the green
 - b) Squad get-together, training and practice
 - c) Report punctually at prescribed times
 - d) Adhere to any curfew which may be imposed by the Team Manager
 - e) Comply with any requirements of the Team Manager, the Chief Executive (or nominated representative) or any other Bowls England official
4. Make the Team Manager or other relevant person representing Bowls England aware of any medication being taken prior to or when participating in Trials/Squad days and International Events.
5. Inform the Team Manager of any personal circumstances that may affect his/her performance in the team.
6. Adhere to Bowls England's Betting Integrity Guidance (*Bowls England Regulation No. 4*).
7. Adhere to Bowls England's Disciplinary Regulations (*Bowls England Regulation No. 9*).
8. Adhere to Bowls England's Anti-Doping Guidance (*Please refer to Bowls England website*).
9. Adhere to Bowls England's Equality Policy (*Please refer to Bowls England website*).
10. Not render himself/herself unfit through alcohol or drugs on or off the bowling green.
11. Adhere to a No Smoking Policy (including electronic devices) during all international events.
12. Show respect to colleagues, opponents and officials and not subject them to any physical or verbal abuse at any time.
13. Not to give an interview to the press or media without the permission of the Team Manager whilst on International duty and, if given permission, to conduct himself/herself in a manner befitting a person representing their country.
14. Adhere to Bowls England Social Media Policy (Please refer to Bowls England website – *the following key points are shown for your information below*):
 - a) You shall not post information or make comments that could bring Bowls England into disrepute or which are derogatory or disrespectful in any way to Bowls England or anyone associated with it
 - b) Comments should not be speculative or have an actual or likely negative impact on Bowls England's reputation or cause embarrassment to Bowls England, its partners, employees, clients and players or be intended to do the same or be posted without proper regard to the potential for harm
 - c) You shall not post any pictures or statements that may embarrass another member of Bowls England or the National Governing Body itself
15. Players shall leave the confines of the green with their bowls once their own game is finished and shall not return to the green until all matches are completed.
16. Any players representing Bowls England in the British Isles Championships should adhere to the following:
 - a) Hotel Accommodation (including meals) for all players shall be arranged by Bowls England for the duration of the event and booked as a group
 - b) All British Isles players should remain together for the duration of the event and while representing England should remain as a team, including travel and meals under the direction of the British Isles Championship Team Manager
 - c) Spectators, spouses and guests shall make their own arrangements
